# WAKE NOW OUR VISION COLLABORATIVE CAMPAIGN Legacy Challenge

# WAKE NOW OUR VISION LEGACY CHALLENGE — LOW HANGING FRUIT THAT WILL SPOIL QUICKLY!

Wake Now Our Vision requires no grant committee, no competition, and no approval by any official UUTC group. You are in complete control, and you have the power to strengthen

various arms of Unitarian Universalism, including UUTC. But you need to act quickly.

Wake Now Our Vision Legacy Challenge is designed to encourage new *legacy* giving. A legacy gift is a gift of cash, securities or other property that is realized after you die through a beneficiary designation or your will. New legacy gift intentions made between January 1, 2017 to June 30, 2020 will qualify for a matching program as *long as matching funds remain*. If the receiving institution is unaware of an earlier intention, it will still qualify as new. The matching amount is 10% up to \$10,000 and the match comes from the Shelter Rock Congregation. In other words, a gift up to \$100,000 dollars will be matched by a gift from Shelter Rock in the amount of \$10,000. A \$100 gift will be matched by a gift in the amount of \$10. If no approximate amount is supplied, or if the gift cannot be accurately valued at this time, a flat match of \$1,000 will be given. Charitable Gift Annuities will count for this flat match. *Of the five million pledged by Shelter Rock, 53% has already been allocated to match gifts already made.* 

**UUA** groups that qualify for these matching gifts are Church of the Larger Fellowship, Starr King School for the Ministry, UU Minister's Association, Meadville Lombard Theological School, the UUA, UUSC, The Mountain Retreat & Learning Center, and qualified UU Congregations such as UUTC.

If your gift to UUTC is listed as a percentage of your assets, then Shelter Rock will provide a flat match of \$1000. However, unlike your legacy gift, the contributions from Shelter Rock will begin paying out this summer to your selected groups. Don't miss this chance to amplify your giving. Fill out and sign a Legacy Challenge form and submit with supporting documentation. Forms may be found on the office counter, or downloaded from the website, below. ### **UUTC TREASURER'S TERM REPORT**

### July 1 FY2015-16 to June 30 FY2017-18



My three terms began with the retirement of the Rev. Ernie Mills and expired with the Rev. Ilene Kaur Tomkins-Gillispie nearing the end of her first year of settled ministry. In between was a kaleidoscope of change and growth.

The work of the Warm & Dry capital campaign that put on a new roof, added insulation, and installed a modernized sound and video system for the sanctuary had completed. We awaited the arrival of our first interim minister, the Rev. Paula Gable. And the Settled Minister Search Committee went to work. Many thanks are due to Bruce Kirkman, Joanna Bliss, Lauren Agrella-Sevilla, Betty Kendrick, Earle Rabb, and Ben Browning for their selfless hard work in finding the Rev. Ilene Tompkins-Gillispie for us!

The Rev. Paula spearheaded making the Church Administrator a full-time position, and so RK Young became our first full-time employee outside the ministry. RK and Rev. Paula began Team Meeting Night, an

opportunity for all the teams to meet, interact as necessary, and gain insight from the minister as their organizational leader. Policy and procedures were established to begin offering musical and speaking events open to the public, which necessitated NC sales tax registration and consultation with a CPA over UBIT (unrelated business income tax). Events have been well attended and it is hoped they continue, as they provide a source of non-congregational income.



A new church management software package that will grow with us no matter how large or complex we may become was installed and operational by September of 2015, thanks to the foresight of the Board during our cherished Peg Hall's tenure as President of that body. We continue to renovate and beautify our space through donations to the Sponsored Projects fund, an idea initiated by our beloved Gary Kendrick during his term as President of the Board. Sponsored Projects has been responsible for \$54,775.55 of improvements since its inception.

The Rev. Gable left us, and we were close to signing a contract with the Re. Cynthia Prescott when she passed away from a heart attack. With the greatest of luck, we were able to have the Rev. Ian White Maher fill our 2<sup>nd</sup> year interim slot. And lucky it was, as the candidate pool had closed for the year.


During the interim ministry of Rev. Ian, we purchased not one, but three adjoining properties in January of 2017, an endeavor many of our congregants participated in both financially and materially through donations of time and talent (*read: manual labor*), and treasure – the financial donations that **continued page 4**

were integral to the renovations, and the furnishings supplied from our attics and basements for the Women's Oxford House. Fiscal Year 2017-2018 saw our first positive return from the Varsity Project – we added \$3,420.00 in rental income to the Operating Fund. The balance of the rental monies went to additional necessary improvements to our new properties. Fiscal year '18-'19 should see most of the rental income supplement the Operating Fund.

Our electrical and gas usage has remained fairly constant over the past few years despite increased use of our facility; due to prudence in installing upgraded and additional insulation, installation of smart thermostats, and changeovers to LED lighting. We average 3,000kw of electricity and 20 therms of natural gas use per month. Most of our electricity is now purchased from green and renewable energy generation sources.





### **Endowment Fund**

"I do want to explain that I think many people (including me) have felt that contributing to the Endowment Fund wasn't doing anything for UUTC now, and that the \$100,000 threshold was far away; so maybe some folks couldn't get excited about it. I don't know why it didn't occur to me earlier that making my legacy gift now was so much better, because UUTC could benefit from it in the immediate future, rather than waiting for me to die. And I will be able to see that happening."


In July of 2015 when I began my first term as your Treasurer, the endowment fund had a balance of \$18,288.20. By December of that year the balance rose to \$38,715.33. The Board of Trustees codified policy concerning the Endowment Fund in early 2017 to read:

### **Endowment Fund.**

The UUTC endowment fund supports an enduring investment in the mission of UUTC. To that extent the funds may only be placed in socially responsible investments as with the UUA Common Endowment Fund, or similar vehicle. The intent is that the principal of the fund remains intact and grow with time. To that goal no withdrawals may be made from the Endowment Fund before the principal reaches \$100,000.00. Withdrawals may be made each fiscal year in the amount of 50% of the current year's interest on continued page 5

the principal, provided the principal is above the minimum set forth. The fund income may be used for community outreach, social justice, or educational and spiritual exploration programs. The fund income is not intended for and may not be used for operating or capital budget expenditures, except in the case of extraordinary need, where not using these funds threatens the existence of UUTC, as determined by the Board, and then only with the approval of 75% of the membership present at a quorum advertised 30 days in advance.



With our balance now exceeding the required minimum withdrawals may begin next spring and our Endowment Fund will be producing results in our community.

### Compliance

We completed our first ever financial review by an outside CPA firm the spring of 2018, and passed with only minor recommendations, several of which were immediately implemented. A copy of the report is in the church office.

### Future Recommendations

- A. UUTC receives 89% of its operating income from the pockets and purses of its congregation. *This is not a recommended nor fiscally safe situation*. Income for a religious organization needs to have diverse sources so that it is not financially threatened should a large donor suddenly leave. The recommended safe level for congregational revenue is less than 80%.
  - UUTC should consider using its facilities to generate income outside of its membership.
  - The Board of Trustees and the Finance Committee should consider the income potential of every planned event or activity as a matter of course.
- B. It is a given that cutting costs and minimizing investment in infrastructure is not a long-term solution for maximizing revenues. A business entity, and a religious organization is a business entity, must invest in itself to increase revenues. A well-maintained, attractive building creates desire to belong, and to rent the facilities. Events and activities supported by suggested donations brings people that may become interested in Unitarian Universalism or will pay to attend hosted events. Any hosted activity or event open to the public should generate sufficient revenue to be at least self-supporting. Rental properties can provide long-term steady income, and with forethought can remain tax-free. Providing community services such as childcare and education should operate at a net profit to benefit our congregation. It is not sufficient to cover our costs.

C. UUTC should prioritize strategic planning. We are too complex to "wing it by the seat of our pants" any longer. Large decisions need to be considered in light of long-term planning. Depreciation on many assets is complete and plans for replacement are non-existent.

### Conclusion

I have been truly honored to serve as your Treasurer for three terms. It has been a pleasure and a personal growth experience to work with the five Stewardship Teams, and the three Finance Committees and Boards of Trustees. UUTC is blessed to have so many highly experienced people within diverse fields willing to serve this congregation.




### IF YOU ARE A MEMBER, THE BEST DIRECTORY IS ON YOUR SMARTPHONE

Contact Directories are really important for us all to stay connected. But did you know that the **ChurchLife** app is available to Members? It is easy to use and is the most up-to-date resource for reaching other members of UUTC.

You can download and install the app from either Google Play or the Apple App Store. Before you can use it, however, you will need a password from our ACS database.

To get that password, go to our Member page on the website: <a href="http://uutc.org/member/">http://uutc.org/member/</a>, scroll down to the red "ACS" logo and click on it. It will direct you to the ACS login/get a password page. On that page, look below the login box for "Need a Password," and enter your email there. This will connect you to ACS and they will email you with a way to select a password to use with the ChurchLife app.

If you do not receive an email from Access ACS/UUTC within a few hours, and you use Comporium email, call Comporium Tech Support and ask them to release this email from your Spam folder. Since the email does not look like our "usual," they assume that it's bad stuff and are trying to protect you. They will ask you to verify the last four digits of your SSN to make sure you are you, and they can fix this very quickly. Then you can complete the password process and start connecting!


### **SCHOOL SUPPLIES**

Aging is not a choice. Aging wisely is. This is an invitation to join Don and Linda Lander and a group of your fellow UUs in community and share your journey as you pursue the goal of aging wisely. We will read the book *Aging* 



Wisely by Rabbi Rachel Cowan and Dr. Linda Thal as a guide.

Some quotes from the book: "What does retirement mean now that there are so many opportunities for learning, for caring, for serving? We can redefine aging."

"If the opportunity arises, consider forming your own group of friends and others who are wrestling with these matters, for spiritual work often flourishes best when supported by community."

The course is designed to create this kind of supportive community. To that end the group will adopt a covenant, an agreement as to how we will conduct ourselves in the group. Most importantly the covenant includes: Extending and presuming welcome. Listening actively without judgment. No interrupting, fixing or advice giving. Everyone will have the chance to share as deeply as they wish and it is not "share or die." Confidentiality will be maintained. Members are asked to share their own truth and experience.

The book contains many "Reflection Questions." Answering these questions from our own experience will keep the sharing of the group on topic. The book also contains exercises and help in establishing a spiritual practice.
